IF PERMISSION FOR PARKING IS GRANTED, I WILL OBEY THE FOLLOWING RULES:

1. A student wishing to park on the campus must complete this registration form. After approval, a parking decal will be issued and must be hung or placed in the proper location designated by the school. Each student must agree not to sit in the car during school hours and to observe speed regulations. **STUDENTS MUST EXIT VEHICLE WITHIN THREE (3) MINUTES OF PARKING IN THEIR ASSIGNED PARKING SPOT AND REPORT TO THE COMMONS AREA OR BREAKFAST.**
2. School officials reserve the right to search or authorize the search of a car parked on campus or any location of a school sponsored activity if there is reason to suspect it might contain drugs, weapons, or other unauthorized or illegal objects. It is the responsibility of each student who drives an automobile or operates a vehicle to make absolutely sure that no firearms/ammunitions such as guns or rifles, brought to school. Additionally, it is illegal to bring nightsticks, bats, knives, or any other type of object that may be used for violence. **IMPORTANT: ANY AND ALL ITEMS FOUND IN A STUDENT'S VEHICLE ARE CONSIDERED THE PROPERTY OF THE VEHICLE'S OWNER; STUDENTS WILL DISCIPLINE IN ACCORDANCE WITH THE CODE OF STUDENT CONDUCT FOR ANY ITEMS FOUND TO BE IN VIOLATION OF THE AFOREMENTIONED POLICY.**
3. A student using his/her vehicle to leave campus without permission during the time he/she is scheduled for classes (this includes lunch) will be subject to having his/her registration revoked. **There will be a 10-day loss of driving privilege for violation of the above.**
4. Student must park in the student parking lot on the east side of the building unless written permission is obtained from the administration.
5. Prior approval must be obtained from the administration in order to leave an automobile on campus overnight.
6. **THE DESOTO COUNTY SCHOOL BOARD AND/OR DESOTO COUNTY HIGH SCHOOL ARE NOT RESPONSIBLE FOR ACTS OF VANDALISM, THEFT, OR ANY OTHER LOSS FROM AUTOMOBILES PARKED ON THE SCHOOL CAMPUS.**
7. Students and parents must remember that parking on campus is a **privilege not a right.**
8. Vehicle driven must be registered with the high school. If you may be driving multiple vehicles, please register **each** vehicle.

PARKING/TARDY POLICY

1. Students who drive to school must adhere to the school tardy policy as stated in the student Code of Conduct.
2. Students who violate the school tardy policy run the risk of losing parking privileges.
3. Students who accumulate three tardies during 1st period will be subject to losing their parking decals for 10 days.
